



Highlights of PT Cikarang Listrindo Tbk's Sustainability Achievements During 2021



Jakarta, May 9, 2022 - On April 30, 2022, PT Cikarang Listrindo Tbk (IDX: POWR) ("the Company") published its Sustainability Report 2021 with the theme "Paving a Sustainable Future" that is an integral part of the Annual Report 2021 with the theme "Building a Resilient Recovery ". The Sustainability Report 2021 theme describes the Company's strategic steps towards sustainability in the future. This is done through the preparation of the Sustainability Roadmap 2030 as a guideline for the Company in achieving Environmental, Social, and Governance (ESG) management targets, as well as generating sustainable added value for stakeholders.

In the midst of a challenging pandemic, Cikarang Listrindo strives to consistently make a positive contribution to stakeholders and society, as well as the environment by developing renewable energy technologies and various sustainability initiatives. One of the important highlights of the Company's sustainability efforts is implementing the recommendations of the Task Force on Climate-Related Financial Disclosure (TCFD), as a form of commitment and

real contribution to preventing climate change. Currently, Cikarang Listrindo is one of the few listed entities in Indonesia that initiates an early adoption of TCFD reporting incorporated in its 2021 Sustainability Report.

TCFD is established by the Financial Stability Board (FSB) in December 2015. Currently, Environmental, Social, and Corporate Governance reporting using the TCFD framework is mandatory in G7 countries, such as Canada, France, Germany, Italy, Japan, United Kingdom, and United States.

One of the other important steps in 2021, the Company succeeded in setting a target of reducing GHG emissions by 20% in 2030, in line with the commitment of national contribution to reducing emissions for the energy sector (Nationally Determined Contribution/NDC) of 19%. Our efforts to achieve the target are through increasing the use of Rooftop Solar Power (PLTS) technology as a source of power generation options for customers, as well as using biomass fuel to replace a portion of coal in CFPP Babelan.

With the various efforts and initiatives undertaken, the Company recorded a total CO₂ emission equivalent of operating generating units at 3 (three) generating locations, head office, and service offices during 2021 resulting in an emission intensity of 0.68 GHGe/MWh. This intensity is lower than the 2019 intensity of 0.71 GHGe/MWh. This reduction in emission intensity is an effort to reduce GHG emissions by the Company. This calculation has been verified by a third party, namely Transpacific Certifications Limited in accordance with the requirements of ISO 14064-1:2018. For its commitments and sustainability initiatives in 2021, on April 22, 2022, the Company proudly received the award of Green Elite for emission reduction and Platinum Plus for transparency of emission calculations from the Bumi Global Carbon Foundation and Investor Magazine. Both are the highest honors given in award ceremonies.



The Company has appointed an independent third party, PT Moores Rowland Indonesia, to carry out an assurance process with the ISAE3000 standard for the Sustainability Report 2021, with the aim of verifying the contents of the report, especially on material topics. With the spirit of "Powering the Goodness", the Company is fully committed to making a positive contribution to all stakeholders, both to the community around the Company's operational locations and outside the area, by carrying out operational activities in accordance with the principles and formulation of the Sustainable Development Goals (SDG). Currently, the Company contributes to 16 of the 17 SDGs.

Cikarang Listrindo at a glance

Cikarang Listrindo is the first private power utility listed in the Indonesian Stock Exchange since 2016. The Company is also the pioneer private power utility in Indonesia that started serving customers since 1993 and currently serving more than 2,500 industrial customers in five industrial estates in Cikarang, and has also supplied electricity to Perusahaan Listrik Negara (PLN) since 1996. The Company's generating capacity of 1,144 MW added with renewable energy Solar Rooftop of 5.5 MWp as of March 2022, makes the Company as one of the biggest capacity power producer in Indonesia.

The Company consistently continues to provide the best services and quality to the customers and creates added values for all stakeholders. This is proved by the achievement of various awards during 2021 such as the "Indonesia Best Public Company 2021 with Valuable Earnings Performance" from Warta Ekonomi Research and Consulting, the "Indonesia Best CSR Award with Outstanding Program in Waste Management Commitment" from Warta Ekonomi, IICD Top 50 Big Caps with GCG Best Practices, "Certificate Gold Champion" in the Public Company category and "Best Award Disaster Management" from Bisnis Indonesia Corporate Social Responsibility Award (BISRA) 2021, and appreciation awards for the Company's active participation in assisting the handling of COVID-19 in Bekasi Regency from the Regent of Bekasi, the appreciation of the "Management BBB" rating at the ESG Awards 2021 by Berita Satu Media Holding, the Gold Rank for the Company's Sustainability Report 2020 and "A Commendation for first year ASSRAT" by National Center for Sustainability Reporting, Top GCG award in energy sector by The Iconomics, and Indonesia Most Acclaimed CEO Award 2021. The last award received by PT Cikarang Listrindo Tbk is the PROPER blue for GFPP Jababeka and CFPP Babelan.
